

# Spectra Inc. Closes Private Placement

For Immediate Release – August 4, 2006

Toronto, Ontario – Spectra Inc. (SSA: TSX VENTURE), reports that it has closed a non-brokered private placement of 1,570,000 units at a price of 5 cents per unit for gross proceeds of \$78,500. Each unit is comprised of one common share in the capital of Spectra and one non-transferable share purchase warrant. Each share purchase warrant entitles the holder to purchase one additional common share of Spectra for a period of 24 months from closing at an exercise price of 10 cents per share.

Cash finders fees of 6 per cent of the gross proceeds of the offering and 98,910 warrants are payable. All shares, warrants and any shares issued upon exercise of the warrants with respect to the above private placements are subject to a hold period and may not be traded for four months plus one day from the date of issuance.

Spectra Inc. is a vertically integrated supplier of innovative products and services to the Commercial Transportation Industry and the Professional Trucker. Spectra's product line increases productivity, reduces maintenance costs and improves fleet safety and includes Brake Safe<sup>®</sup> and SureStroke<sup>™</sup>, visual brake stroke indicators, Brake Inspector<sup>®</sup> an innovative, advanced electronic air brake diagnostic system and the Termin-8R<sup>™</sup> line of anti-corrosion and extreme pressure lubricants.
